JOB SUMMARY/ESSENTIAL FUNCTIONS: Operate mosquito control spray truck 4 to 6 hours per evening as needed. Work with a variety of pesticides. Prepare and maintain routine records of operations. Load and unload equipment/supplies as required. Perform other duties as assigned.

QUALIFICATIONS:

High School graduate or equivalent, or six (6) months related experience. Driving experience required.

Valid driver's license for South Carolina. Must have safe driving record.

Ability to read and follow county maps.

Ability to work evenings, including some weekends as needed.

Ability to read and understand written and oral instructions with regard to treatment locations and safety measures.

Departmental testing may be administered during interview.

A criminal background check will be completed on selected applicant if a current one (less than 3 years old) is not on file.

PHYSICAL REQUIREMENTS:

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to handle, feel or operate objects, tools, or controls. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl; and talk and hear. The employee must frequently lift and/or move up to thirty (30) pounds. Specific vision abilities required by this job in both daylight and by artificial light in evenings, include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus. The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

This is a safety sensitive position and subject to random drug and alcohol testing.
