**JOB SUMMARY/ESSENTIAL FUNCTIONS:** Perform routine maintenance of County's right-of-way and drainage easements which may include operating chainsaws to cut trees and limbs in the right-of-way, operating of commercial weed eaters, operate bush hogs and side arm cutters and operating earth compactors during installation and repair of storm drainage system or roadways. Operate county vehicles to include small dump trucks. Perform other duties as assigned.

**QUALIFICATIONS:**

Must be at least eighteen (18) years of age.

High school graduate or equivalent and two (2) years related experience.

Valid driver's license for South Carolina. Must have safe driving record. **Must have or be able to obtain Commercial Driver's License within 6 months of employment.**

Ability to read and write. Good mathematical skills preferred.

Departmental testing may be administered during interview.

Completed degree(s) beneficial to the position may be partially considered as work experience.

A criminal background check will be completed on selected applicant if a current one (less than 3 years old) is not on file.

**PHYSICAL REQUIREMENTS:**

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to handle, feel or operate objects, tools, or controls. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl; and talk and hear. The employee must frequently lift and/or move up to ninety-five (95) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus. The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

**SAFETY INFORMATION/DUTIES:**

This is a safety sensitive position and subject to random drug and alcohol testing. All employees holding such jobs or requesting promotion or transfer to such jobs are subject to drug testing. May be required to work extra hours and to perform extra or different duties during emergency situations.
