JOB SUMMARY/ESSENTIAL FUNCTIONS: Under the instruction and supervision of the Lead Electrician, perform installation, trouble shooting, and repair of electrical panels, switching devices, electrical circuits and fixtures, both low and high voltage. Apply information from electrical blue prints and circuit schematics in the performance of duties. Operate and maintain equipment used in the electrical trade. Use all proper safety procedures as required by the code of the electrical trade. May assist in other trades as needed. Perform other duties as assigned.

QUALIFICATIONS:

Must be at least eighteen (18) years of age.

High school graduate or equivalent and four (4) years related electrical experience. Extensive knowledge of facility type hardware preferred.

Ability to comprehend complex electrical blueprints and circuit schematics.

Ability to read and write.

PHYSICAL REQUIREMENTS:
