DEPARTMENT: FACILITIES AND GROUNDS

JOB SUMMARY/ESSENTIAL FUNCTIONS: Under the instruction and supervision of the lead carpenter, assist other carpenters in moderate to complex skilled maintenance duties in the carpentry trade including but not limited to construction, renovations, and remodeling throughout county owned and/or operated facilities. Assist in troubleshooting, repairs and replaces all types of building hardware to include commercial and industrial type locks, doors and windows. Performs other duties including assembly, repair, and replacement of office furniture and cabinetry. Assist other trades routinely and performs other duties as assigned.

QUALIFICATIONS:

Must be at least eighteen (18) years of age.

High school graduate or equivalent and three (3) years related carpentry experience. Extensive knowledge of facility type hardware preferred.

Ability to read and write.

Valid driver's license for South Carolina. Must have safe driving record.

Departmental testing may be administered during interview.

Completed degree(s) beneficial to position may be partially considered as work experience.

A criminal background check will be completed on selected applicant if a current one (less than 3 years old) is not on file.

PHYSICAL REQUIREMENTS:

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to handle, feel or operate objects, tools, or controls. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl; and talk and hear. The employee must frequently lift and/or move up to ninety-five (95) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus. The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

SAFETY INFORMATION/DUTIES:

This is a safety sensitive position and subject to random drug and alcohol testing. All employees holding such jobs or requesting promotion or transfer to such jobs are subject to drug testing. Attends all required safety training, follows safety policies and procedures and uses appropriate PPE (Personal Protective Equipment) for assigned tasks.

HOURS OF WORK/MISCELLANEOUS INFORMATION:

This position is classified as non-exempt and reports directly to the Skilled Technician 5 – Lead Carpenter. Thirty-seven and one half (37.5) hours per week. Normal work hours are 7:00 a.m. to 3:00 p.m. Monday through Friday. This position requires "on-call" status on a rotating basis as well as after hours and weekends on an emergency basis. Scheduled hours/days, job location, duties and any other information contained herein is subject to change. May require on call status on a rotating basis. May be required to work extra hours and to perform extra or different duties during emergency situations.
