DEPARTMENT: MAGISTRATE COURT – GOOSE CREEK

JOB SUMMARY/ESSENTIAL FUNCTIONS: Perform various duties in the Small Claims area of the Goose Creek Magistrate Office including data entry for cases, continuance requests and assisting the public. Diversified duties include basic typing, creating files, filing, answering telephones, taking messages, copying, light data entry and computer operation. Location and hours of work are subject to change at any time. Performs other duties as assigned.

QUALIFICATIONS:

High school graduate or equivalent and six (6) months related administrative experience. Legal experience preferred.

Clerical skills including filing, customer service, math, data entry and correct grammar usage.

Data Entry/Basic Skills test score of 55 is required for this position.

Skilled in the use of general office equipment.

Departmental testing may be administered during interviews.

Completed degree(s) beneficial to the position may be partially considered as work experience.

A criminal background check will be completed on selected applicant if a current one (less than 3 years old) is not on file.

PHYSICAL REQUIREMENTS:

This position requires the employee to frequently sit and use hands to handle or operate objects, tools, or controls; and reach with hands and arms. The employee is required to walk, talk and hear. The employee must occasionally lift and/or move up to twenty five (25) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus. The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

SAFETY INFORMATION/DUTIES:

Attends all required safety training, follows safety policies and procedures and uses appropriate PPE (Personal Protective Equipment) for assigned tasks.

HOURS OF WORK/MISCELLANEOUS INFORMATION:

This position is classified as non-exempt and reports directly to the Goose Creek Magistrate Judge. This position will not exceed twenty nine (29) hours per week. This position may work in any office as assigned and work schedule may be subject to change. Scheduled hours/days, job location, duties and any other information contained herein is subject to change. May be required to work extra hours and to perform extra or different duties during emergency situations. Hours of operation and scheduled days are determined by the Magistrate and are subject to change.
