ENVIRONMENTAL SYSTEMS VEHICLE OPERATOR (PS101408)

DEPARTMENT: BCWS – TREATMENT PLANT

JOB SUMMARY/ESSENTIAL FUNCTIONS: Under general supervision, perform specialized skilled work in the operation of tandem axle, triaxle, quad axle and tractor-trailer dump trucks used in the transport of wastewater sludge from the county's treatment facilities to the landfill or other approved sites for disposal. Assist the Environmental Systems Operators in the operation of sludge dewatering equipment when needed. Receive, monitor, and mix chemicals utilizing a forklift, and load HTH chlorine drums into the back of a standard pickup truck. Load and unload vehicle as required assuring all safety rules and regulations are being followed during the process. Perform routine maintenance and cleaning tasks with a variety of hand tools for equipment, buildings and grounds. Perform visual and auditory inspections of dump trucks, plant dewatering equipment and maintain appropriate logs. Perform other duties as assigned.

QUALIFICATIONS:

Must be at least eighteen (18) years of age.

High school graduate or equivalent, and one (1) year of vehicle operating or comparable experience.

Must have a valid **Class B CDL** for South Carolina with a safe driving record, and the ability to obtain and maintain a valid **Class A CDL** within six (6) months of employment.

Ability to read and write.

Must have a strong mechanical aptitude and be able to follow written and oral instruction with minimum supervision.

Must working knowledge of the proper operation, safety precautions, and occupational hazards involved in operating heavy equipment.

Must be able write legible and descriptive reports on duties performed.

Departmental testing may be administered during interview.

A criminal background check will be completed on selected applicant if a current one (less than 3 years old) is not on file.

PHYSICAL REQUIREMENTS:

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to handle, feel or operate objects, tools, or controls. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl; and talk and hear. The employee must frequently lift and/or move up to sixty-five (65) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.

SAFETY INFORMATION/DUTIES:

This is a safety sensitive position and subject to random drug and alcohol testing. All employees holding such jobs or requesting promotion or transfer to such jobs are subject to drug testing. Attends all required safety training, follows safety policies and procedures and uses appropriate PPE (Personal Protective Equipment) for assigned tasks.

HOURS OF WORK/MISCELLANEOUS INFORMATION:

This position is classified as non-exempt and reports directly to the Chief Operator. Forty (40) hours per week at eight (8) hour days. Normal working hours are Monday through Friday from 7:00a.m. until 3:00p.m. Scheduled hours/days, job location, duties and any other information contained herein is subject to change. May be required to work extra hours and to perform extra or different duties during emergency situations. ***This position DOES NOT require a Biological Wastewater Treatment Plant Operator Certification for employment.***
