JOB SUMMARY/ESSENTIAL FUNCTIONS: Perform skilled craft duties in the operation of various heavy equipment and vehicles, including vac truck, in the cleaning maintenance of stormwater systems. Utilizes high pressure sprayers with cleaning nozzles and other equipment for removal of debris and sediment; vacuums debris and sediment from access points, such as stormwater manholes and pipe inlets and outlets. Performs routine preventive and corrective maintenance on vehicles and equipment, including changing tires, and requiring basic knowledge of gasoline and diesel engines, mechanical systems and hydraulics. May supervise other heavy equipment operators and maintenance workers. Responsible for individual work site safety including traffic control and confined space entry compliance. Utilizes GIS and Grid maps to locate and document work to be done. Maintain records and logs of work performed. Perform other duties as assigned.

QUALIFICATIONS:

High school graduate or equivalent and four (4) years related construction experience.

Must have and maintain a valid **Commercial Driver's License (CDL) CLASS B** license for South Carolina with Tanker endorsement and a safe driving record. Class A CDL with Tanker and HAZMAT endorsements preferred.

Ability to use pneumatic power tools and general mechanics tools.

Ability to read and write. Strong mathematical skills preferred.

Departmental testing may be administered during interview.

Completed degree(s) beneficial to the position may be partially considered as work experience.

A criminal background check will be completed on selected applicant if a current one (less than 3 years old) is not on file.

PHYSICAL REQUIREMENTS:

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to handle, feel or operate objects, tools, or controls. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl; and talk and hear. The employee must frequently lift and/or move up to ninety-five (95) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.
