JOB SUMMARY/ESSENTIAL FUNCTIONS: Assist with the operation of various heavy equipment and vehicles, including vac truck, in the cleaning maintenance of stormwater systems. Utilize high pressure sprayers with cleaning nozzles and other equipment for removal of debris and sediment; vacuum debris and sediment from access points, such as stormwater manholes and pipe inlets and outlets. Operate light equipment and vehicles, including light dump trucks. Assist with performance of routine preventative and corrective maintenance on vehicles and equipment, including changing tires. Responsible for individual work site safety including traffic control and confined space entry compliance. Utilize GIS and Grid maps to locate and document work to be done. Assist with records and logs of work performed. Perform other duties as assigned.

## **QUALIFICATIONS:**

High School graduate or equivalent, or one (1) year related maintenance experience.

Must have and maintain a valid driver's license for South Carolina with a safe driving record. Class B CDL license with Tanker endorsement preferred.

Ability to use pneumatic power tools and general mechanics tools.

Ability to read and write.

Departmental testing may be administered during interview.

Completed degree(s) beneficial to the position may be partially considered as work experience.

A criminal background check will be completed on selected applicant if a current one is not on file.

#### PHYSICAL REQUIREMENTS:

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to handle, feel or operate objects, tools, or controls. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl; and talk and hear. The employee must frequently lift and/or move up to ninety-five (95) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus. The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.
