JOB SUMMARY/ESSENTIAL FUNCTIONS: Perform a complex level of skilled craft duties in the painting trade, to include all aspects of painting and furniture finishing, as well as field painting such as parking lot striping, stenciling, and traffic painting. Inspect quality assurance of other painters. Perform general maintenance in the painting field to buildings, grounds, and equipment such as pressure washers, paint sprayers and tools. Perform sheetrock work such as finishing seams and sanding in preparation for paint applications. May assist staff in other trades as needed. Provide material quotes and estimates on an as needed basis. Perform other duties as assigned.

QUALIFICATIONS:

High School graduate or equivalent and two (2) years related experience. Candidates with commercial experience preferred.

Must have and maintain a valid driver's license for South Carolina with a safe driving record.

Ability to read and write.

Departmental testing may be administered during interview.

Completed degree(s) beneficial to the position may be partially considered as work experience.

A criminal background check will be completed on selected applicant if a current one is not on file.

PHYSICAL REQUIREMENTS:

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to handle, feel or operate objects, tools, or controls. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl; and talk and hear. The employee must frequently lift and/or move up to ninety-five (95) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus. The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

SAFETY INFORMATION/DUTIES:

This is a safety sensitive position and subject to random drug and alcohol testing. All employees holding such jobs or requesting promotion or transfer to such jobs are subject to drug testing. Attends all required safety training, follows safety policies and procedures and uses appropriate PPE (Personal Protective Equipment) for assigned tasks.

HOURS OF WORK/MISCELLANEOUS INFORMATION:

This position is classified as non-exempt and reports directly to the Lead Painter. Thirty-seven and one half (37.5) hours per week. Normal work hours are 7:00 a.m. to 3:00 p.m. Monday through Friday with the ability to work after hours when necessary. **This position may be required to perform "on-call" status on a rotating basis as well as after hours and weekends on an emergency basis.** Scheduled hours/days, job location, duties and any other information contained herein is subject to change. May be required to work extra hours and to perform extra or different duties during emergency situations.
