**VEHICLE OPERATOR (PS101613)**

**DEPARTMENT: STORMWATER MANAGEMENT PROGRAM**

**JOB SUMMARY/ESSENTIAL FUNCTIONS:** Perform skilled craft duties in the operation of various heavy equipment and vehicles, including vac truck, in the cleaning maintenance of stormwater systems. Utilizes high pressure sprayers with cleaning nozzles and other equipment for removal of debris and sediment; vacuums debris and sediment from access points, such as stormwater manholes and pipe inlets and outlets. Performs routine preventive and corrective maintenance on vehicles and equipment, including changing tires, and requiring basic knowledge of gasoline and diesel engines, mechanical systems and hydraulics. Primary operator of maintenance axillary truck. Responsible for ensuring proper site safety equipment is with the crew at all times including traffic control devices and confined space entry equipment is available and in proper working condition. Responsible for individual work site safety including traffic control and confined space entry compliance. May occasionally be the primary heavy equipment (vac truck) operator and supervise maintenance worker. Utilizes GIS and Grid maps to locate and document work to be done. Maintain records and logs of work performed. Perform other duties as assigned.

**QUALIFICATIONS:**

High school graduate or equivalent and two (2) years related construction experience.

Must have and maintain a valid driver's license for South Carolina with a safe driving record. **Must have or be able to obtain a Class B Commercial Driver's License for South Carolina with Tanker Endorsement within six (6) months of employment. Class A CDL with Tanker and HAZMAT endorsements preferred.**

Ability to use pneumatic power tools and general mechanics tools.

Ability to read and write.

Departmental testing may be administered during interview.

Completed degree(s) beneficial to the position may be partially considered as work experience.

A criminal background check will be completed on selected applicant if a current one (less than 3 years old) is not on file.

**PHYSICAL REQUIREMENTS:**

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to handle, feel or operate objects, tools, or controls. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl; and talk and hear. The employee must frequently lift and/or move up to ninety-five (95) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus. The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

This is a safety sensitive position and subject to random drug and alcohol testing. All employees holding such jobs or requesting promotion or transfer to such jobs are subject to drug and alcohol testing. Attends all required safety training, follows safety policies and procedures and uses appropriate PPE (Personal Protective Equipment) for assigned tasks.

**This position is classified as non-exempt and directly to the Stormwater Coordinator.** Thirty-seven and one half (37.5) hours per week. Normal working hours are Monday through Friday from 8:00 a.m. until 4:00 p.m. with the ability to work flexible when necessary. Must be able to work extended hours and weekends when required due to construction schedules. Scheduled hours/days, job location, duties and any other information contained herein is subject to change. May be required to work extra hours and to perform extra or different duties during emergency situations.
